Investment Objective

To achieve RBA Cash +4.0% p.a before fees over rolling nine year periods.

Investment Strategy

The portfolio has exposure to a diverse mix of managed fund investments, which include primarily growth assets and may have some exposure to interest-producing assets. Over the long term, the portfolio aims to have a 10% allocation to defensive assets and a 90% allocation to growth assets. Capital volatility is expected due to a high exposure to growth asset classes.


The portfolio is constructed around an asset allocation based on the strategy's long term objectives. The portfolio and asset allocation are reviewed to adapt to changes in market conditions. The asset allocation, selection and blending of managed funds are actively managed with a strong focus on risk. 





