### **Investment Objective**

To achieve RBA Cash +2.5% p.a before fees over rolling five year periods.

#### **Investment Strategy**

The portfolio has exposure to a diverse mix of managed fund investments, which include both interestproducing and growth assets. Over the long term, the portfolio aims to have a 50% allocation to defensive assets and a 50% allocation to growth assets. Some capital volatility is expected due to exposure to growth asset classes.


The portfolio is constructed around an asset allocation based on the strategy's long-term objectives. The portfolio and asset allocation are reviewed to adapt to changes in market conditions. The asset allocation, selection and blending of managed funds are actively managed with a strong focus on risk. Fund managers, their funds and the construction of the portfolio are regularly reviewed for suitability and market conditions.




