Investment Objective

To achieve RBA Cash +1.6% p.a before fees over rolling three year periods.

Investment Strategy

The portfolio has exposure to a diverse mix of managed fund investments, which include primarily interest-producing and some growth assets. Over the long term, the portfolio aims to have a 70% allocation to defensive assets and a 30% allocation to growth assets. The portfolio aims to reduce the probability of a negative return through a high exposure to more defensive assets.

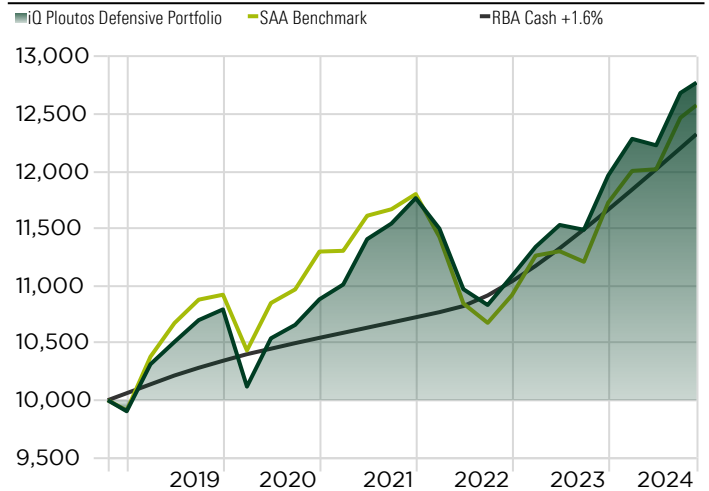
The portfolio is constructed around an asset allocation based on the strategy's long-term objectives. The portfolio and asset allocation are reviewed to adapt to changes in market conditions. The asset allocation, selection and blending of managed funds are actively managed with a strong focus on risk. Fund managers, their funds and the construction of the portfolio are regularly reviewed for suitability and market conditions.

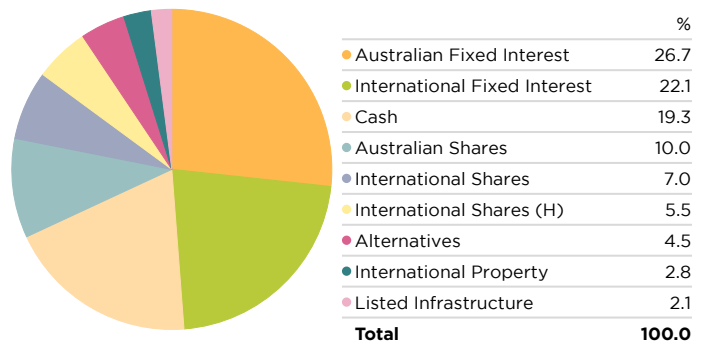

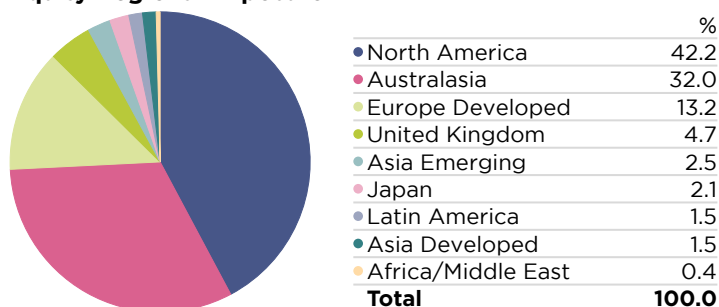

Asset Allocation

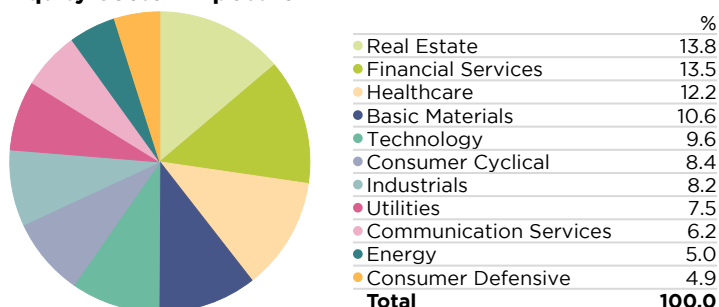
